### About Dave's Clinics

Dave takes a common sense approach to handling dogs based on the needs of the livestock. Using teamwork and communication, he focuses on the handler communicating with the dog and allowing the dog to communicate with the livestock. His goal is to give handlers the tools necessary to understand livestock and to be able to communicate just what is necessary for the dog to accomplish the tasks. This approach allows the handler and dog to work together to accomplish their tasks and not just navigate obstacles.
